# A budget committed to the principles of Antyodaya

s the budget for the year 2018-19 was presented in the parliament, the roadmap of a strong, vibrant and prosperous India was laid before the nation. The interests of most deprived sections of the society, farmers, women, youth, senior citizens and infrastructure sector along with fiscal prudence and discipline were given priority in the budget. A comprehensive budget aimed at uplifting the poorest of the poor in the society and committed to the principles of Antyodaya, it caters to the aspirations of almost every section of the society. The vision of providing LPG gas connection, electricity and toilet to every home has been adequately addressed by increase in allocations to Ujjwala, Saubhagya and Swachh Mission. At the same time it has addressed different sectors of economy, strengthening them with futuristic vision and goals while envisaging a vibrant rural and urban sector in the country.

The budget is in the line of previous budgets wherein the farmer, poor and rural sector have been prioritized and agriculture sector has remained in its main focus. The decision to offer MSP at 1.5 times the cost of the farming is set to revolutionise the agricultural sector transforming the lives of the farmers while strengthening the base of Indian economy. The vision of 'New India' envisaged by the Prime Minister aims at doubling the

farmers' income by 2022 now appears within range with such revolutionizing steps aided by new initiatives in allied agricultural activities including fisheries, animal husbandry, bamboo farming etc. But the biggest announcement came in the form of health cover to around 50 crore people in the country who under the health protection scheme were provided treatment in secondary and tertiary sector with a coverage upto 5 lac rupees. Considered to be the biggest health coverage scheme in the world, it promises to provide health security to 10 crore families in the country. The health sector has remained a priority area for the government having earlier reduced prices of medicines, stents and knee transplantation ensuring dialysis and other health related facilities which were hitherto out of reach for a large section of the society. The decision to open new medical colleges will further strengthen health infrastructure in the country and make health facilities available to common people.

One of the most important aspects of the budget is that it adheres to fiscal prudence with fiscal deficit pegged at 3.5 % and projected at 3.3% for 2018-19. A number of structural reforms measures are slated to take the economy on higher growth trajectory focussing on manufacturing, services and exports. The increase in custom duty will incentivise domestic sectors and help in generating employment opportunities while strengthening 'Make in India' initiatives. The budget has also made significant provisions for health, education, employment, SCs, STs, senior citizens, MSMEs, power, railways and infrastructure sector. It has overall given a huge impetus to the economy ensuring its momentum in the days to come.

The budget is guided by the vision the Prime Minister who has ensured that the government remains committed to the welfare of farmers, poor, women, youth and SCs and STs. At the same time it focuses on the principles of 'reform, perform and transform' with the mantra of 'Sabka Saath, Sabka Vikas'. It has been rightly called a pro-India budget which refuses to fall prey to hollow populism having an eye on elections, but underlines the vision of a developed, strong and prosperous India. The Prime Minister Narendra Modi and Finance Minister Arun Jaitley should be congratulated for taking bold initiative in the national interests and heralding an era of responsible, accountable and transparent political culture in the country. As BJP National President has said that the budget has given new wings to the aspirations of the poor, the budget is a huge step towards, 'Ease of Living' for the poor and lower middle and middle class people.

### MSP OF CROPS INCREASED TO ONE AND HALF TIMES OF PRODUCTION COST

In line with the government's objective of doubling farmers' income, the Minimum Support Price (MSP) for all hitherto unannounced crops of Kharif was raised to at least one and half times of their production cost.

### **TWO MAJOR INITIATIVES IN HEALTH SECTOR**

(i) Health and Wellness Centre: The National Health Policy, 2017 has envisioned Health and Wellness Centres as the foundation of India's health system. Under this 1.5 lakh centres will bring health care system closer to the homes of people. These centres will provide comprehensive health care, including for non-communicable diseases and maternal and child health services. These centres will also provide free essential drugs and diagnostic services. The Budget has allocated Rs.1200 crore for this flagship programme. Contribution of private sector through CSR and philanthropic institutions in adopting these centres is also envisaged.

(ii) National Health Protection Scheme: The second flagship programme under Ayushman Bharat is National Health Protection Scheme, which will cover over 10 crore poor and vulnerable families (approximately 50 crore beneficiaries) providing coverage upto 5 lakh rupees per family per year for secondary and tertiary

- Hike in deduction limit for health insurance premium

and/ or medical expenditure from Rs. 30,000 to Rs. 50,000 under section 80D.

- Increase in deduction limit for medical expenditure for certain critical illness from Rs. 60,000 (in case of senior citizens) and from Rs. 80,000 (in case of very senior citizens) to Rs. 1 lakh for all senior citizens, under section 80DDB.
- Proposed to extend Pradhan Mantri Vaya Vandana Yojana up to March, 2020. Current investment limit proposed to be increased to Rs. 15 lakh from the existing limit of Rs. 7.5 lakh per senior citizen.
- More concessions for International Financial Services Centre (IFSC), to promote trade in stock exchanges located in IFSC.
- To control cash economy, payments exceeding Rs. 10,000 in cash made by trusts and institutions to be disallowed and would be subject to tax.
- Tax on Long Term Capital Gains exceeding Rs. 1 lakh at the rate of 10 percent, without allowing any indexation benefit. However, all gains up to 31st January, 2018 will be grandfathered.
- Proposal to introduce tax on distributed income by equity oriented mutual funds at the rate of 10 percent.
- Proposal to increase cess on personal income tax and corporation tax to 4 percent from present 3 percent.
- Proposal to roll out E-assessment across the country to almost eliminate person to person contact leading to greater efficiency and transparency in direct tax collection.
- Proposed changes in customs duty to promote creation of more jobs in the country and also to incentivise domestic value addition and Make in India in sectors such as food processing, electronics, auto components, footwear and furniture.

### **OFFERED FARMERS A HIGHER MSP**

### **3** TOWARDS UNIVERSAL HEALTHCARE



care hospitalization. This will be the world's largest government funded health care programme. Adequate funds will be provided for smooth implementation of this programme.

In order to further enhance accessibility of quality medical education and health care, 24 new Government Medical Colleges and Hospitals will be set up, by upgrading existing district hospitals in the country. This would ensure that there is at least 1 Medical College for every 3 Parliamentary Constituencies and at least 1 Government Medical College in each State of the country.

### **RELIEF TO SENIOR CITIZENS: EXEMPTION OF** INTEREST INCOME ON DEPOSITS INCREASED TO **RS 50.000**

With the objective of providing a dignified life to senior citizens, the general budget proposes significant



incentives for senior citizens. Presenting the General Budget 2018-19 in Parliament, the Finance Minister said that the exemption of interest income on deposits with banks and post offices to be increased from Rs. 10,000/- to Rs. 50,000/- and TDS shall not be required to be deducted on such income, under section 194A. This benefit shall be available also for interest from all fixed deposits schemes and recurring deposit schemes.

The Finance Minister also announced raising the limit of deduction for health insurance premium and/ or medical expenditure from Rs. 30,000/- to Rs. 50,000/-, under section 80D. All senior citizens will now be able to claim benefit of deduction up to Rs. 50,000/- per annum in respect of any health insurance premium and/or any general medical expenditure incurred.

### ALLOCATION FOR SCs AND STs INCREASED

In the General Budget 2018-19 in Parliament the total earmarked allocation for SCs in 279 programmes has been increased from Rs.34,334 crore in 2016-17 to Rs.52,719 crore in RE 2017-18. Likewise, for STs, earmarked allocation has been increased from Rs.21,811 crore in 2016-17 to Rs.32,508 crore in RE 2017-18 in 305 programmes. The Finance Minister said that earmarked allocation has been further increased to Rs.56,619 crore for SCs and Rs.39,135 crore for STs in BE 2018-19.

### 5.22 CRORE FAMILIES BENEFITTED UNDER PRADHAN MANTRI JEEVAN JYOTI BEEMA YOJANA

The Union Minister for Finance and Corporate Affairs, Shri Arun Jaitely stated that the Pradhan Mantri Jeevan Jyoti Beema Yojana (PMJJBY) has benefitted 5.22 crore families with a life insurance cover of Rs.2 lakh on payment of a premium of only Rs.330/- per annum. Likewise, under Pradhan Mantri Suraksha Bima Yojana, 13 crore 25 lakh persons have been insured with personal accident cover of Rs.2 lakh on payment of a premium of only Rs.12 per annum. The Minister further added that the Government will work to cover all poor households, including SC/ST households, under these in a mission mode. The Government will expand the coverage under Prime Minister Jan Dhan Yojana by bringing all sixty crore basic accounts within its fold and undertake measures to provide services of micro insurance and unorganized sector pension schemes through these accounts.

Under "Beti Bachao Beti Padhao", Sukanya Samriddhi Account Scheme launched in January 2015 has been a great success. Until November, 2017 more than 1.26 crore accounts have been opened across the country in the name of girl-child securing an amount of Rs.19,183 crore, the Minister added.

### BUDGET 2018 EXTENDS CONCESSION TO MSMEs IN PUSH TO FORMALIZE INDIAN ECONOMY

The Union Budget 2018 extended concession to micro, small and medium enterprises (MSMEs), as part of the government's efforts to bring businesses under the formal economy's fold. The budget proposed to cut the corporate tax rate to 25% for companies with annual revenue of up to Rs250 crore. The budget also earmarked Rs3 trillion for 2018-19 under the Pradhan Mantri Mudra Yojana or Mudra scheme. In addition, the budget provided Rs3,794 crore for credit support, capital and interest subsidy to MSMEs.

### EKALAVYA SCHOOLS FOR TRIBAL CHILDREN

The Union budget has proposed that the government will launch a series of residential schools for students from the scheduled tribes (STs), in view of the social discrimination faced by tribal communities. By 2022, every block with more than 50% ST population and at least 20,000 tribal persons will have an Ekalavya Model Residential School.

### GOBAR-DHAN SCHEME TO IMPROVE LIVES OF VILLAGERS

In an effort to make the villages open defecation free and improving the lives of villagers, the Union budget planned the launch of Galvanizing Organic Bio-Agro Resources Dhan (GOBAR-DHAN). It will manage and convert cattle dung and solid waste in farms to compost, bio-gas and bio-CNG. The Finance Minister Shri Arun Jaitley informed while presenting budget that 187 projects have been sanctioned under Namami Gange Programme for infrastructure development, reverse surface cleaning, rural sanitation and other interventions at a cost of Rs.16, 713 crore. 47 projects have been completed and remaining projects are at various stages of execution All 4465 Ganga Grams villages on the bank of river have been declared open defecation free.

# A farmer friendly, common citizen friendly and development friendly budget: PM

ongratulating Finance Minister Shri Arun Jaitley for the Budget, Prime Minister Shri Narendra Modi said "This budget strengthens the foundation stone of New India. The budget focus is on issues ranging from agriculture to Infrastructure. On one hand, budget covers aspects such as health plans to address the concerns of the poor and middle class, while on the other hand it has plans to increase the wealth of small entrepreneurs in the country. Other aspects range from food processing to fiber optics, from road to shipping, concerns of youth and the senior citizens, from rural India to Ayushman India and Digital India to Start up India."

He added "Our farmers have contributed in a big way towards the progress of the country with a record production of fruits and vegetables. Several steps have been proposed in this budget to give a boost to the farmers and enhancing their income. A record allocation of Rs. 14.5 lakh crores has been made for rural development and agriculture. Dalits, oppressed and disadvantaged sections of the society will be benefited with out of 51 Lakh new homes, more than 3 lakh kilometers of roads, about 2 crore toilets, electricity connections in 1.75 crore households. These initiatives will create new opportunities especially in the rural areas. He said, In our country, the cooperative societies are exempted from paying income tax. But the 'Farmer Producer Organization' -FPO, that is similar to the cooperative societies, does not get this benefit. Therefore, income tax exemption for the 'Farmer Producer Organization' -FPO, which mint for the welfare of the farmers, is a welcome step. By providing the linkages between the Self Help Groups for women engaged in organic, aromatic and herbal cultivation and the 'Farmer Producer Organizations' the income of the farmers will be increased. Similarly, the Gobar-Dhan Yojana will help in keeping the village clean, while increasing the income of farmers and cattle herders.

He added Ujjwala Yojana has not only provided a relief to the poor women from the smoke but also become a huge source of their empowerment. I am happy to note that the target for Ujjawala has been

Special emphasis has been given to the development of infrastructure related to Digital India. Allocation of Rs. 6 lakh crores has been made which is Rs. 1 lakh crore more than the previous year. 

# Economic Survey Predicts 7-7.5 Percent Growth in 2018-19

series of major reforms undertaken over the past year will allow real GDP growth to reach 6.75 percent this fiscal and will rise to 7.0 to 7.5 percent in 2018-19, thereby re-instating India as the world's fastest growing major economy. This was stated in the Economic Survey 2017-18 tabled in Parliament today by the Union Minister for Finance and Corporate Affairs, Shri Arun Jaitley. It said that the reform measures undertaken in 2017-18 can be strengthened further in 2018-19.


The survey underlines that due to the launch of transformational Goods and Services Tax (GST) reform on July 1, 2017, resolution of the long-festering Twin Balance Sheet (TBS) problem by sending the major stressed companies for resolution under the new Indian Bankruptcy Code, implementing a major recapitalization package to strengthen the public sector banks, further liberalization of FDI and the export uplift from the global recovery, the economy began to accelerate in the second half of the year and can clock 6.75 percent growth this year.

The survey points out that as per the quarterly estimates; there was a reversal of the declining trend of GDP growth in the second guarter of 2017-18, led by the industry sector. The Gross Value Added (GVA) at constant basic prices is expected to grow at the rate of 6.1 per cent in 2017-18 as compared to 6.6 per cent in 2016-17. Similarly, Agriculture, industry and services sectors are expected to grow at the rate of 2.1 per cent, 4.4 per cent, and 8.3 per cent respectively in 2017-18. The survey adds that after remaining in negative territory for a couple of years, growth of exports rebounded into positive one during 2016-17 and expected to grow faster in 2017-18. However, due to higher expected increase in imports, net exports of goods and services are slated to decline in 2017-18.


Similarly, despite the robust economic growth, the savings and investment as a ratio of GDP generally declined. The major reduction in investment rate occurred in 2013-14, although it declined in 2015-

16 too. Within this the share of household sector declined, while that of private corporate sector increased.

The survey points out that India can be rated as among the best performing economies in the world as the average growth during last three years is around 4 percentage points higher than global growth and nearly 3 percentage points higher







than that of Emerging Market and Developing Economies. It points out that the GDP growth has averaged 7.3 per cent for the period from 2014-15 to 2017-18, which is the highest among the major economies of the world. That this growth has been achieved in a milieu of lower inflation, improved current account balance and notable reduction in the fiscal deficit to GDP ratio makes it all the more creditable.

Though concerns have been expressed about growing protectionist tendencies in some countries but it remains to be seen as to how the situation unfolds. Some of the factors could have dampening effect on GDP growth in the coming year viz. the possibility of an increase in crude oil prices in the international market. However, with world growth likely to witness moderate improvement in 2018, expectation of greater stability in GST, likely recovery in investment levels, and ongoing structural reforms, among others, should be supporting higher growth. On balance, country's economic performance should witness an improvement in 2018-19.

The survey highlights that against the emerging macroeconomic concerns, policy vigilance will be necessary in the coming year, especially if high international oil prices persist or elevated stock prices correct sharply, provoking a "sudden stall" in capital flows. The agenda for the next year consequently remains full: stabilizing the GST, completing the TBS actions, privatizing Air India, and staving off threats to macro-economic stability. The TBS actions, noteworthy for cracking the longstanding "exit" problem, need complementary reforms to shrink unviable banks and allow greater private sector participation.

The GST Council offers a model "technology" of cooperative federalism to apply to many other policy reforms. Over the medium term, three areas of policy focus stand out: Employment: finding good jobs for the young and burgeoning workforce, especially for women. Education: creating an educated and healthy labor force. Agriculture: raising farm productivity while strengthening agricultural resilience. Above all, India must continue improving the climate for rapid economic growth on the strength of the only two truly sustainable engines—private investment and exports.

# Union Budget 2018: Railways allocation hiked to record Rs 1.48 lakh crore

ifi and CCTVs will be provided in all trains and there will be escalators at stations with 25,000plus footfall, said finance minister Arun Jaitley. The Union Budget has allocated a record Rs1.48 lakh crore for Indian Railways to raise its carrying capacity and improve the train travel experience.

Of this, Rs1.46 lakh crore is capital expenditure, while Rs2,028 crore is to reimburse operating losses on strategic lines and reimburse Indian Railway Catering and Tourism Corporation for the operational cost of e-ticketing.

In the last budget, finance minister Shri Arun Jaitley had waived service charges on railway e-tickets to encourage cashless transactions. The charges waived were Rs 40 for AC class and Rs 20 for sleeper class.

Shri Jaitley said a large part of the expenditure is for capacity creation, and mentioned different initiatives

being taken.

These include track doubling, and third and fourth line works of 18,000 km; 5,000 km of gauge conversion; redeveloping 600 railway stations, equipping them with Wi-Fi and CCTV cameras; introduction of modern train-sets; and escalators for stations with footfalls over 25,000.

Shri Arun Jaitley said Mumbai's suburban rail system is being expanded at cost of Rs10,000 crore, and an additional suburban network worth Rs40,000 crore was also being planned. Similarly, 160 km of rail network worth Rs17,000 crore has been planned for Bengaluru.

"Once the 18,000km expansion and 5,000km doubling is done, railways will once again emerge as a preferred mode of travel. Rs73,000 crore for security is historic," said Railway Minister Shri Piyush Goyal.

## **Industry players welcomed Union Budget**

ndustry players welcomed the Budget and government's move to double the allocation for the Digital India programme to Rs 3,073 crore -- a decision that will help research and skilling in Robotics, Artificial Intelligence (AI) and Internet of Things (IoT), among others.

Presenting the Union Budget, Finance Minister Shri Arun Jaitley said that NITI Aayog will initiate a national programme to direct efforts in AI and the Department of Science and Technology will launch a Mission on Cyber-Physical Systems.

"The National Programme on Artificial Intelligence to be set up by Niti Aayog, the 5G testbed in IIT Chennai and the mission to encourage Big Data, cyber security and Robotics are some of the initiatives that will help promote Industry 4.0," said President of the Internet & Mobile Association of India (IAMAI).

# Congress Government in Karnataka is on exit doors: PM Modi



o mark the end of the Parivarthana rally taken out by BJP State President Shri BS Yeddyurappa from November last year, PM Shri Narendra Modi addressed a massive rally at the Palace grounds in Bengaluru on 05 February, 2018. Noteworthy, the 90day Parivarthana Yatra, which was flagged off by BJP National President Shri Amit Shah on 01 November, passed through 224 Assembly constituencies in the State finally culminated in Bengaluru.

When facilities are provided to villages, migration to the cities will go down and the mounting pressure on cities will be eased."

After the BJP came at the Centre, it was decided to allot Rs 2 lakh crore to Karnataka. # 67 FDI proposals of 11,703 cr approved during April-December 2017

s many as 67 foreign direct investment proposals worth Rs 11,703 crore were approved during the first nine months of the ongoing fiscal; the Rajya Sabha was informed on 06 February, 2018. Minister of State for Finance Shri P Radhakrishnan said "the government has cleared 67 FDI proposals worth Rs 11,703 crore during the period April 1, 2017 to December 31, 2017".

An FDI proposal worth Rs 532 crore of Metaffinity Pvt Lt, an investment holding company, got the government's nod, the minister said. "The foreign invest is to be brought in by two foreign investors, viz Canada Pension Plan Investment Board and Pantheon-HK Project Universe, LP, for up to 49 per cent stake in the form of non-voting equity share of Metaffinity Pvt Ltd," as per the reply.

### INDIA REMAINS FASTEST GROWING DOMESTIC AVIATION MARKET IN 2017

India remained the world's fastest growing domestic aviation market for the third straight year in 2017 as economic and network expansion bolstered the sector, according to global airlines' body IATA. Globally, Revenue Passenger Kilometres (RPKs) — a measure

"The domestic India market posted the fastest full-year growth rate for the third year in a row (17.5 per cent), followed by China (13.3 per cent)," the International Air Transport Association (IATA) said in a report released last week. The grouping noted that such growth rates were driven mainly by the comparatively strong rates of economic expansion seen in each country, as well as stimulus from additional airport pairs being offered.

Such new services translate into time savings for passengers and have a similar stimulatory impact on demand as cuts in airfares, it added. "India posted the fastest domestic RPK growth for the third year in a row, driven by economic and network expansion," the report said. In December also, India registered the highest growth rate of 17.4 per cent. Many Indian carriers have embarked on ambitious expansion plans and local airlines have placed orders for over 900 aircraft. Since late 2014, lower airfares have helped in boosting passenger growth — which in 2017 was also supported by broad-based pick-up in global economic conditions.

# Digital transactions rise to 1.11 billion in January

igital transactions reached a new peak in January in terms of volume after crossing the 1 billion mark. They rose 4.73% to 1.11 billion in January from 1.06 billion in December, according to provisional data released late on 07 February, 2018 by the Reserve Bank of India (RBI).

The overall value of these transactions was also the second highest in a month in the past year. Transactions worth about Rs131.95 trillion were carried out in January through credit and debit cards, the unified payments interface (UPI), unstructured supplementary service data (USSD), prepaid payment instruments (PPIs) and internet banking. The highest so far was in March, at Rs149.59 trillion.

The impact of the government's decision to bear merchant discount rate (MDR) for a period of two years, applicable on transactions made through debit cards, BHIM UPI and Aadhaar-enabled payments system (AEPS), which was implemented from 01 January is clear, with a significant increase in the volume of transactions made through these modes during the month.

Transactions across UPI reached a new peak in January. The transaction volume was 151.7 million, up around 4% from 145.5 million in the previous month. The value of transactions rose around 18% to Rs155.4 billion in January from Rs131.4 billion in the previous month. Out of this, Bharat Interface for Money (BHIM) accounts for 9.57 million transactions, amounting to Rs 3.65 billion.

Transactions through UPI received a major boost from the government after Prime Minister Shri Narendra Modi launched the BHIM app on 30 December 2016. Until now, there have been more than 22.7 million downloads of the app on the Android platform and around 1.10 million downloads on the IOS platform.

UPI is a payment system launched by the National Payments Corporation of India (NPCI) which facilitates instant fund transfer between two bank accounts on the mobile platform without having any details of the beneficiary's bank. UPI was launched in August 2016



with 21 banks, and is currently being offered by about 71 banks.

Usage of PPIs such as mobile wallets reached a new peak in terms of both volume and value during January. The volume of PPI transactions in January was 113.6 million as compared with 99.1 million in December.

Transactions worth Rs38.3 billion were recorded in January compared with Rs35.1 billion in December. The provisional data considers transactions of PPIs issued by eight non-bank issuers for goods and services transactions only.

Debit and credit card usage at point-of-sale (PoS) machines was at its second highest in a month since the government's demonetization exercise in November 2016. The volume of transactions increased by around 1.43% in January to 267.7 million transactions from 263.9 million transactions in the previous month. The highest was in December at 311 million transactions. However, the value of transactions fell by 3% to Rs512.2 billion in January from Rs528.7 billion in the previous month. Card transactions of four banks have been considered by RBI.

Payments using National Electronic Funds Transfer (NEFT) and Real Time Gross Settlement (RTGS) increased by around 1% and 2.4%, respectively, in January from the preceding month.

The government has been pushing to popularize digital payments. Its aim is to grow India's digital economy to \$1 trillion by 2022.

# Services PMI logs fastest growth in 3 months in January, expands to 51.7

he Indian services sector remained in expansion mode in January, registering the fastest rise in activity in three months driven by a renewed increase in new business orders. The seasonally adjusted Nikkei Services Business Activity Index improved to 51.7 in January, up from 50.9 in December, signalling a faster expansion. The index remained above the neutral mark of 50 in January, which separates growth from contraction for the second consecutive month.

In November, the index stood at 48.5. "The recovery across India's services sector continued during January, with growth in output picking up to the joint-strongest since June 2017 as underlying demand conditions improved," said a report of IHS Markit.

As per the report, "Job creation accelerated to the second strongest in over six-and-a-half years." Going



forward, services sector companies in India remained optimistic regarding expected activity levels in 12 months' time.

# India among top three countries where trust in government remains high

ndia continues to be among the top three nations where trust in government remains high, according to the Global Trust Index released annually in Davos. The ranking will reassure the Modi government in the wake of tough reforms like demonetisation and goods and services tax.

India is also in the trust zone as far as how the public sees business, media and NGOs. Its rating remains at 'trust level' with Indonesia and China ahead of it.

The annual Global Trust Index, released by communications marketing firm Edelman in Davos On 29 January, showed that China gained strongly and jumped to the top position whereas the US reported the steepest decline in public trust in its institutions.

The index showed that globally, trust in government, media and NGOs was low as 20 out of 28 countries



surveyed online during October-November last year came in the categories where general population distrusted those institutions. India, as last year, continued to buck this trend.

### **PROSPERITY VERSUS DHARMA**

As these pleasures have no limit a person given to them will always feel a want of wealth and at the same time his addiction to pleasures will reduce his capacity to produce wealth.

### SWADESHI AND DECENTRALISATION

"SWADESHI" and "Decentralisation" are the two words which can briefly summarize the economic policy suitable for the present circumstances. Centralization and monopolization have been the order of the day for all these years, knowingly or unknowingly. The planners have become prisoners of a belief that only large-scale centralized industry is economic and hence without worrying about its ill-effects, or knowingly but helplessly they have continued in that direction. The same has been the case with "Swadeshi" The concept of "Swadeshi" is ridiculed as old-fashioned and reactionary. We proudly use foreign aid in everything, from thinking, management, capital, methods of production, technology, etc. to even the standards and forms of consumption. This is not the road to progress and development. We shall forget our individuality and become virtual slaves once again. The positive content of "Swadeshi" should be used as the cornerstone of reconstruction of our economy.

### **DEPENDENCE ON WESTERN ECONOMICS**

NOT only because of different ideals of life but also because of different conditions in terms of time and place the way of our economic development will have to be different from that of the West. But we are tied to Marshall and Marx. We believe that the economic principles they have discussed are eternal. Even those Who realise that they are dependent upon certain systems are not able to step out of their orbits. The economic prosperity of the West has created a blind belief in us about the Western system of production. Western economists have produced so much critical literature that we easily feel overwhelmed by it. We cannot rise above it. It is possible that this science of economics may have some principles that do not depend upon time, place or system and can prove useful to all, but very few have the capacity to assess this quality. Our education cannot create people with such a capacity. Our economists may be experts in Western economics, but they have not been able to make any solid contribution to it because the Indian economy can neither provide them the necessary thought nor the necessary field for experimentation.

### **NO RIGHT ETERNAL**

NO fundamental rights, whether related to property or other things, are eternal. They are all dependent upon the interest of society. In fact these rights are given to the individual in order that he may perform his social duties. A soldier is given weapons because his duty is to protect society. If he does not do his duty he loses the right to bear weapons. Similarly the right to property is given to an individual so that he could do his duty by society. For this purpose it becomes necessary to define and modify these rights from time to time. No right to property is absolute of society.

### **RIGHT OF OWNERSHIP**

THE right of ownership is actually the right to use a particular thing within definite limits and for a definite purpose. These rights keep changing with the times. Hence as a matter of principle we may not get entangled in the quarrel between the individual's rights and the right of society. For us the State is not the only form of society. We believe that the individual, the family, the community, the State are all different forms in which society expresses and fulfils itself. The

joint family is the practical unit in this country in which we seek to preserve the social sense in the individual, in which every individual has the right to earn, but the right of ownership vests in the family. Wealth is used for the benefit of the family. It is this Indian principle of Trusteeship that has been propounded by Gandhiji, Guruji and other thinkers.

### **OWNERSHIP RIGHT FOR WORKERS**

IT is a matter of surprise that today a share-holder in joint stock companies, who has no other connection with the company except a share in its profit, should be able to exercise ownership rights while the worker who works in an industry, sets its machines into motion and depends upon it for his livelihood should experience a feeling of being a stranger to

it. This feeling is not proper. It is therefore necessary that along with the share-holder the worker should be given ownership rights and a share in its management and profit.

### **RIGHT TO FOOD**

THE slogan commonly heard now-a-days is "one must earn his bread". Normally communists use this slogan, but even the capitalists are not fundamentally in disagreement with it. If there is any difference between them, it is only as regards who earns and how much. The capitalists consider capital and enterprise as important factors of production

and if they take a major share of profit, it is because they think it is their due. On the other hand, communists believe only labour to be the main factor in production. Therefore they concede a major share of production to the labourers. Neither of these ideas is correct. Strictly speaking, our slogan should be that he who earns will feed and every person will have enough to eat. The right to food is a birthright. The ability to earn is a result of education and training. In a society even those who do not earn must have food. The children and the old, the diseased and the invalids, all must be cared for by society. Every society generally fulfils this responsibility. The social and cultural progress of mankind lies in the readiness to fulfil this responsibility.

### **FOOD VERSUS FREEDOM**

WHILE imports may help us tide over our present difficulties, the real solution to the problem lies in maximising agricultural production in the country. That we have not done sufficiently in this direction needs no saying. The present agreement is an eloquent testimony to the Government's failure on this front. With the passage of time we have become increasingly dependent on foreign sources. We fear that due to availability of food in plenty at present the Government may become complacent in their efforts


> to raise production locally. The US Ambassador feels that America is following this policy only to let the struggling people of the democratic world realise that "there can be both freedom and food". But what we want is our freedom and our food. That is possible only if we revive our old slogan of "Freedom from foreign food". Dependence on foreign sources will impoverish and entangle us.

### ECONOMIC DEMOCRACY

IF a vote for everyone is the touch-stone of political democracy, work for everyone is a measure of economic

democracy. This right to work does not mean slave labour as in communist countries. Work should not only give a means of livelihood to a person but it should be of the choice of that person. If for doing that work the worker does not get a proper share in the national income, he would, be considered unemployed. From this point of view a minimum wage, a just system of distribution and some sort of social security are necessary. **(To be continued.)**

In 2014, when Modi wave swept through Uttar Pradesh, Hukum Singh was elected as the Member of Parliament from his hometown. His followers affectionately referred to him as 'Babu Sahab'.

he Prime Minister Shri Narendra Modi replied to the debate on the motion of thanks on the President's address, in the Lok Sabha on 07 February, 2018. The Prime Minister said that India did not get democracy due to Pandit Nehru, as Congress wants us to believe. Exhorting Members to look at our rich history, he said that there are many examples of rich democratic traditions that date back centuries ago. Democracy is integral to this nation and is in our culture, he asserted.

Shri Modi recalled that once when Shri Rajiv Gandhi had landed in Hyderabad, he misbehaved with a Congress leader Mr. T Anjaiah, humiliating a big leader, who did not belong to a privileged background.

How did the Congress act in Kerala, how did they treat the Akali Dal in Punjab, how did they behave in Tamil Nadu, the Prime Minister asked. Why Congress dismissed so many state governments at will, he asked, adding that this does not indicate their commitment to democracy.

We cannot forget how the Congress insulted



Shri Neelam Sanjiva Reddy, a proud son of Andhra Pradesh, the Prime Minister said. They humiliated him, he asserted. Nobody in India needs lessons on democracy from the Congress Party, he said.

In December, did we witness an 'election' or coronation for the post of Congress President, the Prime Minister asked. He noted that one youngster had raised his voice about this as well.

peaking on the motion of thanks on February 5, 2018 on the president's address BJP National President & Rajya Sabha Member Shri Amit Shah said that in 2014 election great people of the country took great decision and after 30 years gave full majority to one party led by Shri Narendra Modi which is giving governance on the principles of 'Antyodaya' and making inclusive development for all. Here, We are giving synopsis of the speech for our esteemed readers:

Hon'ble President, in his speech has mentioned the achievements of this Government. Its analysis is to be welcomed but I want to add a different point of view that this Government got a kind of void in the form of heritage and Government had to devote a lot of time in refilling the same. In the year, 2013 everybody in the country was worried about its future. Women had the feeling of insecurity.

There was no definite policy for securing our borders. Jawans engaged in securing the borders could not even show their valour due to indecisiveness of the government. Youths were agitated. People were worried due to scams and corruption. There was policy paralysis in the government as far as the policy matter are concerned. Then in the year, 2014 during elections, the great people of the country took a historical decision. First time after Independence a non-congress government i.e, BJP Government under the leadership of Shri Narendra Modi was formed. After 30 years, one party got the full majority with the mandate to carry forward the nation and find solution of the problems of the country. This huge mandate was historical. Modi ji was elected the leader of party and he delivered a



historical speech. He said the government which is being formed belongs to poor people, farmers, dalits, backward classes, youths women and tribes. This Government will run on the principles of 'Antyodaya' and make inclusive development for all. During three and half years, Government has completed more than fifty works which will find place in the history of India. In order to fulfil the target of 'Antyodaya', this Government decided to uplift the standard of living of poor people and make the development very meticulously and in this chain opening of Jan-Dhan bank account was the first. So far 3.30 crores people have been provided with the gas cylinder and in this budget Government is making effort to provide cylinders to 8 crore people in place of 5 crore. As far as construction of toilet is concerned, by the year 2022 we will arrange toilet for each house. Existence of toilet in the house not only improves the health but also provides to the women right to live will dignity. This requires neither guarantee nor guarantor and rate of interest is very low. Our Government has electrified 16 thousands villages out of 18 thousands during three and half years.

Government has chalked out a scheme for converting all mandies of the country into e-markets. With neem coating, divergence of urea has completely stopped and its consumption has also gone down. Shut fertiliser plants like Sindri, Barauni, Talcher, Ramagundam and Gorakhpur have resumed production. I hope that with this step there will be no requirement to import urea in this country. A scheme has been formulated for dairy business involving 11,000 crores rupees.

A better initiative has been taken for organic farming. Around 22.5 lakhs hectares of land has been brought under organic farming. Around 3.5 crores of farmers have been given soil health card during the last three years. 460 full-fledged laboratories are functional at present and work relating to setting up of 4,000 mini labs has been initiated. "Darshan from Mysore, Karnataka, has written on My Gov app that he was undergoing an expenditure of Rs 6,000 a month on medicines for the treatment of his father. Earlier, he wasn't aware of the Pradhan Mantri Jan Aushadhi Yojana. But now that he's come to know of the Jan Aushadhi Kendra, he has begun purchasing medicines from there and expenses have been reduced by about 75%. He has expressed that I mention this in Mann Ki Baat, so that it reaches the maximum number of people and they can benefit". He appreciated the Bihar's move to form a human chain to spread awareness about evils of dowry and child marriage. He termed it a unique initiative.

eendayal used to wear khaddar occasionally, but like Lohia, he would not endorse Gandhi's insistence on the promotion of khadi and village industries. And yet his views on the western type of industrial civilization or the Marxist pattern of industrialization resembled those of Gandhi, Said he:

"Not only absence of material prosperity, but its excess leads to the end of Dharma... The west has not thought of the evils resulting from such material prosperity...

Our planners have become prisoners of a belief that only large-scale centralized industry is economic....

We are short of capital . (Therefore), when we think of the means of production in India, we arrive at the firm conclusion that our production process must be labour-intensive."

### **CAPITALISM AND COMMUNISM, NO GOOD**

Gandhi, Lohia and Deendayal—all three were against capitalism as well as communism, Gandhi had placed the ideal of a non-exploitative, egalitarian social order before the world as many had done before. But the uniqueness of his ideal was that the new social order was to be established through non-violent means. "By the non-violent method," he said, "we seek not to destroy the capitalist, we seek to destroy capitalism... Similarly, though he admired the Communist ideals of economic equality and social justice, he rejected bad means for achieving those good ideals. Man is

> not all animal. The spirit in him responds to a call for giving up selfishness. Socialism, according to Gandhi, begins with the first convert. And he claimed that he learnt his lessons in socialism and communism, not from Marxist books, but from the first verse of the Ishavasyopanishad----'Do not covet other person's wealth.'



## FIVE LAKH WI-FI HOTSPOTS FOR RURAL AREAS PROPOSED

In a move aimed at boosting digital technology and telecommunication, the government proposes to set up five lakh Wi-Fi hotspots to provide broadband access to five crore rural citizens with an outlay of Rs 10,000 crore in 2018-19 for creation and augmentation of telecom infrastructure. Shri Arun Jaitley said the task of connecting one lakh gram panchayats through high speed optical fiber network has been completed under phase I of the Bharatnet project. This has enabled broadband access to over 20 crore rural Indians in about 2.5 lakh villages. The government also proposes to set up five lakh Wi-Fi hotspots which will provide broadband access to five crore rural citizens. Allocation of Rs 10,000 crore has been provided in 2018-19 for creation and augmentation of telecom infrastructure.

## READY TO WORK WITH INDIA: NEPAL'S COMMUNIST LEADER KP SHARMA
