Today, more than 4 crore people have been given pucca houses. The dream of many poor people, of having a roof over their heads, has come true.

The PM Ujjwala Yojana has made the kitchens smoke free. Toilets have been provided from the Swachh Bharat Mission. Jal Jeevan Mission led to the provision of tap water. These schemes

have made life dignified.

Farmers Becoming Prosperous

It is a testimony to the commitment of the government towards the farmers that the Ministry of Agriculture was renamed as the Ministry of Agriculture and Farmers Welfare. India's food provider, who was neglected for decades, is now a partner in the development journey.
