New era of judicial ease



We have been freed from the laws made in the British era of the 19th century... after the biggest reform of the 21st century, India has got its own law... which carries the core mantra of justice, equality and fairness... in the true sense, this is the manifestation of the soul of the new India and the principles of the Constitution

The aim is to deliver justice, not punishment

- Freedom from 150-year-old laws made during the British era
- After full implementation of these laws, justice in any FIR across the country will reach up to the Supreme Court in about 3 years
- The new laws also set timelines for completing investigation, filing chargesheets, framing charges and delivering judgments
- For every offence punishable with 7 years or more, forensic investigation has been made mandatory

Key operations and achievements

• 2024

A total of 290 Naxals were killed (the highest in a year in Chhattisgarh), 1,090 were arrested and 881 surrendered

• 2025

Karegutta Hills operation — in 21 days, 31 notorious Naxals were eliminated, with no soldier martyred. The PLGA battalion headquarters was destroyed

1,022 were arrested and 2,337 surrendered

(5 Politburo members returned to the mainstream and 11 were killed)

• 2026

India was declared Naxal-free — The MHA informed all states that from April 2026, no district remains LWE-affected
